The program also assists students in preparing for professional courses such as Company Secretary, Cost and Management Accountant, and Chartered Accountant. A unique feature of the program is that students independently operate a Model Joint Stock Company to bridge the gap between theory and practice. Akriti, a Chennai-based apparel design and event management company came into existence in September 2007. Backed by a determined board and some innovative projects, the newest company on the block is making its presence felt in the corridors of the corporate world. But Akriti is not just another mock model company, it is more than that. The board members, whose roles and positions in the company are well defined, run the company. It started out by announcing the IPO to raise capital for itself. At the moment, the company has about 200 shareholders who own the 517 shares of the company valued at Rs 50 each. This is how the initial principal of Rs. 25,850 was raised.

The company started with Apparel Design as their first venture. Herein they asked people to bring in their old clothes which were modified by designers who were outsourced. Encouraged by the response, they took to designing other things like bags.

The next undertaking was product packaging. Home made chocolates were packaged in formal and informal packages. Companies like Caviakare, Sojreme Industries and The Mobile Store readily brought these packaged chocolates.

Powered by the success, Akriti ventured into event management too. The company conducted the events for the Rotary Club Of Madras. It also organised the All India Employee Conference for Caviakare.

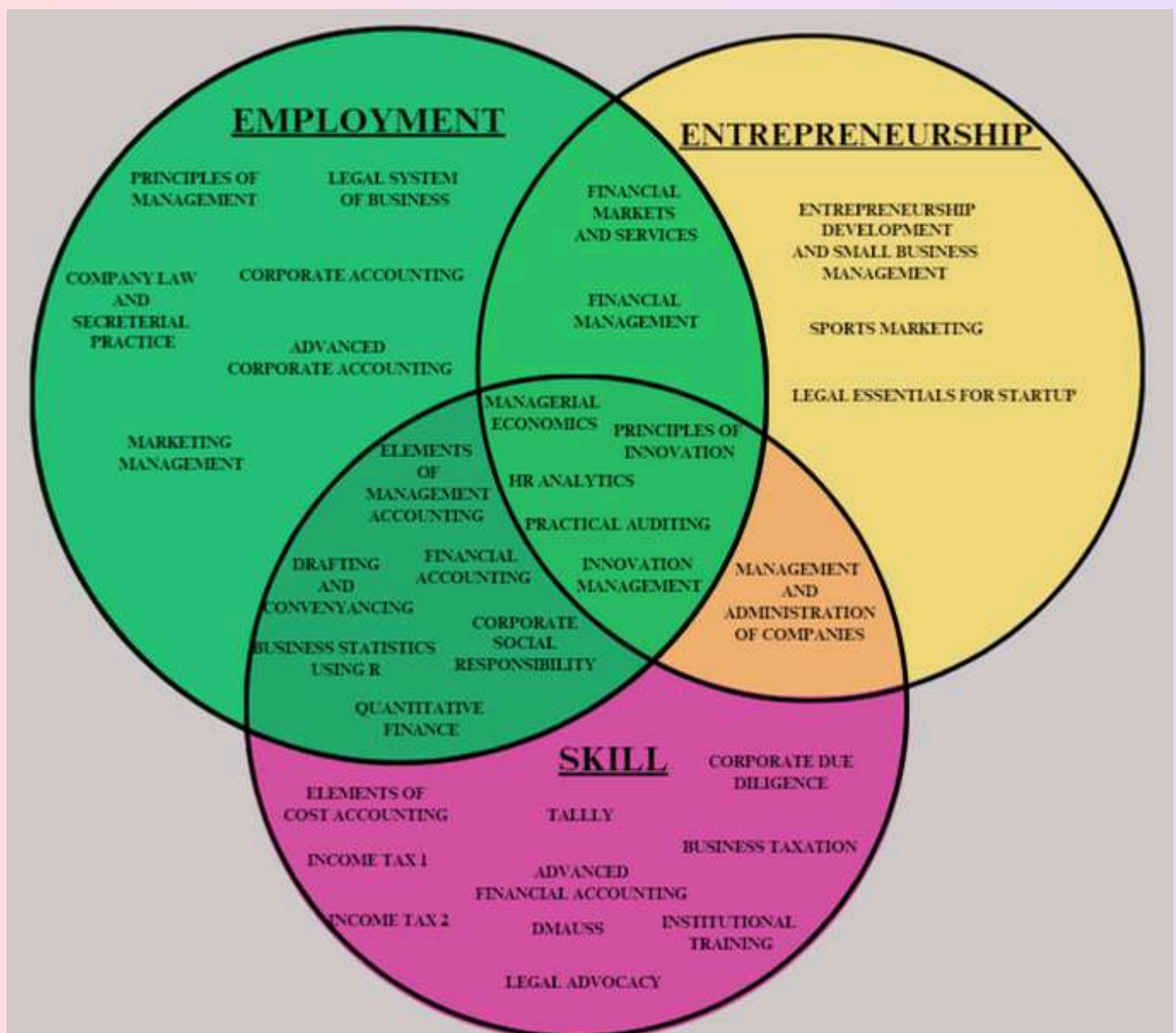

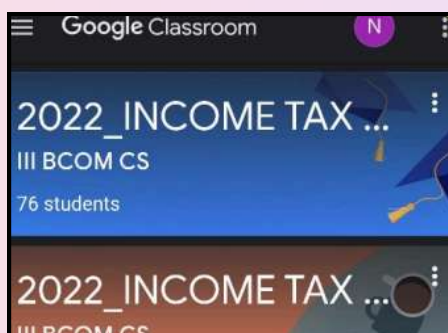
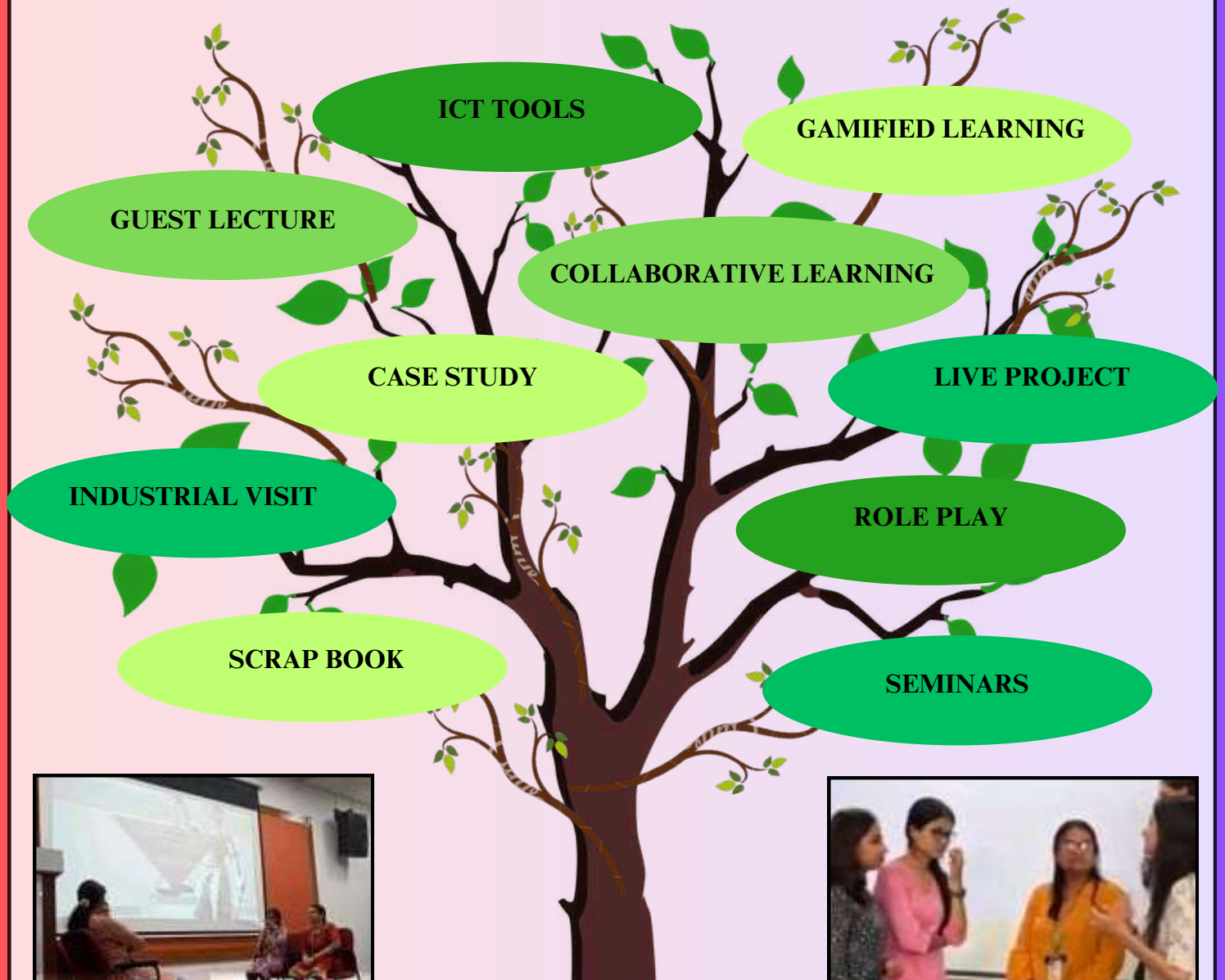
INNOVATIVE CURRICULUM

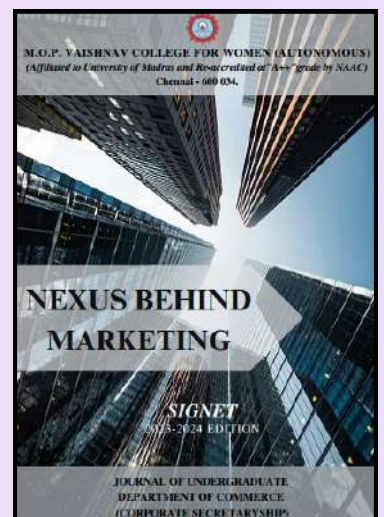

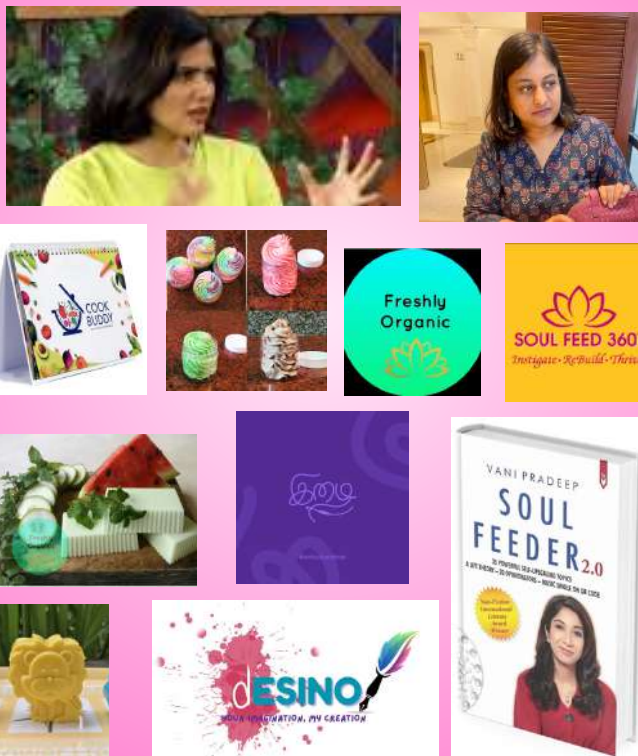

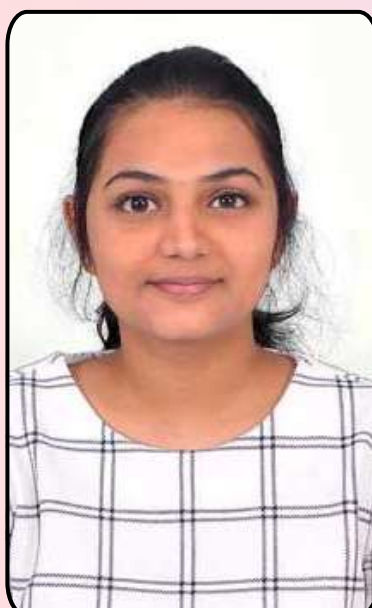
